A market solution for greater ASGM inclusion and impact

Swiss Better Gold provides industry stakeholders with a collaborative and active approach to encourage artisanal and small-scale gold mining (ASGM) to adopt long-term better practices.

ASGM faces significant environmental and social challenges with potentially detrimental impacts.

The Swiss Better Gold Association works with responsible ASGM, from individual panners in Colombia's El Chocó region to medium-scale operations in Peru and Brazil. It also works with the gold industry to set up and monitor supply chains that will help alleviate or resolve these issues.

Launching and maintaining responsible ASGM supply chains isn't without challenges and Swiss Better Gold has been active on a number of fronts:

Scouting and supporting new ASGM that are willing to work towards Swiss Better Gold sourcing criteria,

Monitoring continuous improvements in ASGM practices,

Ensuring local conditions in current and potential new sourcing countries, fostering responsible ASGM and **incentivising** continuous improvement,

Swiss Better Gold is also assessing existing opportunities to expand its impact on ASGM by identifying responsible ways to increase both its upstream and downstream volumes. Thanks to the determination of our members, 2022 saw notable increases in the uptake of Swiss Better Gold by financial markets.

On the institutional front, Swiss Better Gold has worked closely with key industry and supra-governmental institutions to educate on ASGM, as well as propose and support changes that will help ASGM gain or improve access to international markets.

Swiss Better Gold wants to do more in 2023, with the proactive involvement of SECO, its members, responsible ASGM and in-country authorities.

Selecting and approving projects where the Swiss Better Gold premium will be invested,

Working with members to synchronise gold supply and demand,

Channelling mutually beneficial relationships between ASGM and supply chain members.

Swiss Better Gold provides **technical support to policy-makers** in the simplification of the formalization framework, a key issue for scaling-up the supply of responsibly sourced ASM gold as a pre-condition for mining operations to become responsible producers.

Swiss Better Gold also encourages responsible sourcing from ASGM through **knowledge dissemination, sharing of good practices and enhancement of transparency** of the gold sector. Through partnerships and collaboration with identified cooperation programmes, the Initiative contributes to the development of a joint agenda for action in support of responsible ASGM producers. It leverages its broad network at national, regional and international levels and develops further partnerships. A facilitator role is pursued in subnational sectoral roundtables in implementing countries. In Switzerland, the dialogue between different stakeholders interested in ASM gold will be further enhanced and reinforced, contributing to the institutionalised multi-stakeholder dialogue already fostered by SECO and the Swiss Better Gold Association.

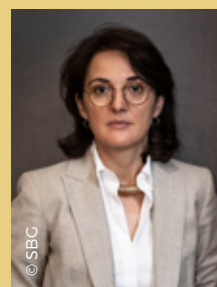

The Swiss Better Gold Association was created in 2013. That same year, in a public-private partnership with the Swiss State Secretariat for Economic Affairs (SECO), the Swiss Better Gold Initiative implemented its first activities in Peru.

Ten years later, Swiss Better Gold has grown in membership, participating countries and the producer network on the ground. It is internationally recognised as a successful initiative in the artisanal and small-scale gold mining sector. The **innovative and collaborative approach** between ASGM miners and the Swiss industrial stakeholders united in Swiss Better Gold was key to the creation of a solid base for this success story. Swiss Better Gold has a **twofold impact**. The first is directly related to **activities undertaken in the field** by Swiss Better Gold implementing partners, together with the gold producers. Our teams support them in reaching the social, environmental and governance expectations of the SBC programme (the SBC sourcing criteria).

The second dimension stems from the **reinvestment in the mining communities and regions** of the SBC impact premium: the Swiss Better Gold Fund (SBC Fund) generated through purchases of Swiss Better Gold by our members. Thanks to this mechanism, together with its network of producers, Swiss Better Gold supports **social and environmental projects on the ground**.



Our key focus is to deliver maximum positive impact to miners who have joined Swiss Better Gold, while planning and reinvesting in ESG programmes on the ground through the Swiss Better Gold Fund.

The Swiss Better Gold Fund (SBG Fund)

The SBG Fund is collected through a simple market mechanism. Swiss Better Gold Association members, who source Swiss Better Gold from accredited producers, pay a **\$1 impact premium per gram of gold purchased**.

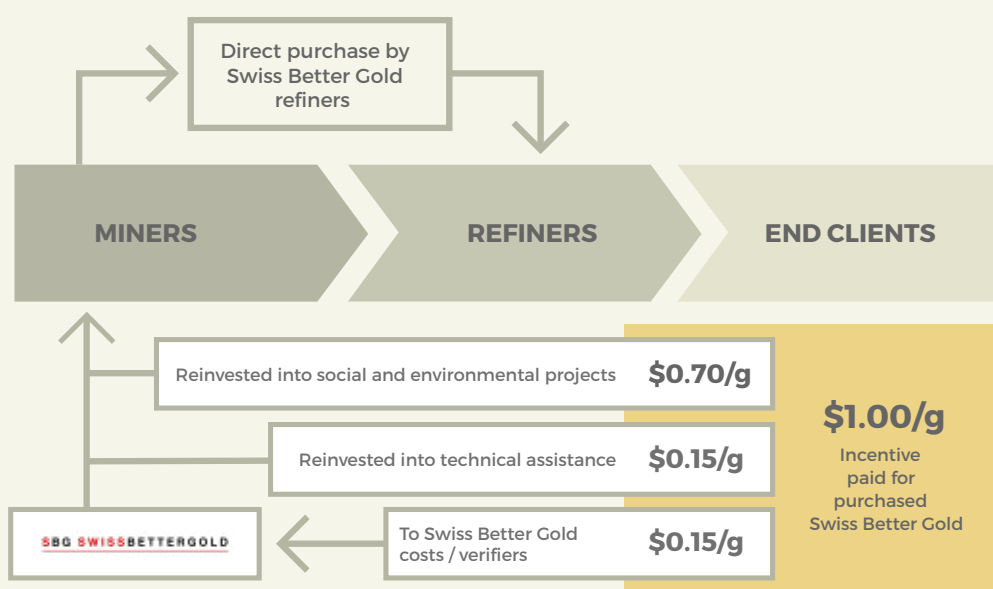
The fund is set up to deliver tangible results and benefits on the ground. Reinvestment from the fund also addresses two important considerations through its positive impacts:

Motivate ASGM operations to remain in the system through co-financing of social and/or environmental projects in their mining or surrounding communities.

Allocate funds to support operations in the early stage of compliance in order to reach full eligibility with SBG criteria.

SBG impact premium



The Swiss Better Gold Fund primarily focuses on supporting the implementation of social and/or environmental projects for ASGM operations that have already reached all ESG expectations of the SBG programme. Additionally, through SBG Fund Technical Assistance, the fund seeks to support operations, that have recently entered the programme, to reach full compliance with the Step 1 Swiss Better Gold criteria in order to establish sustainable long-term foundations for the collaboration with Swiss Better Gold.

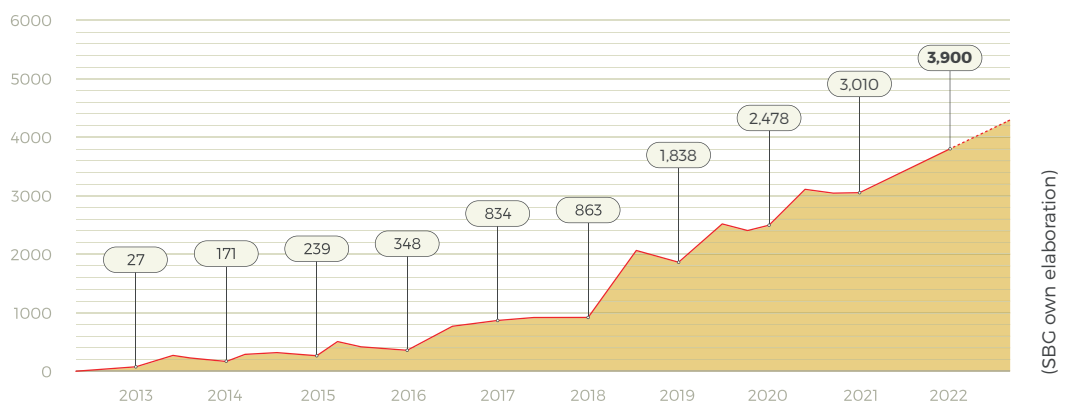

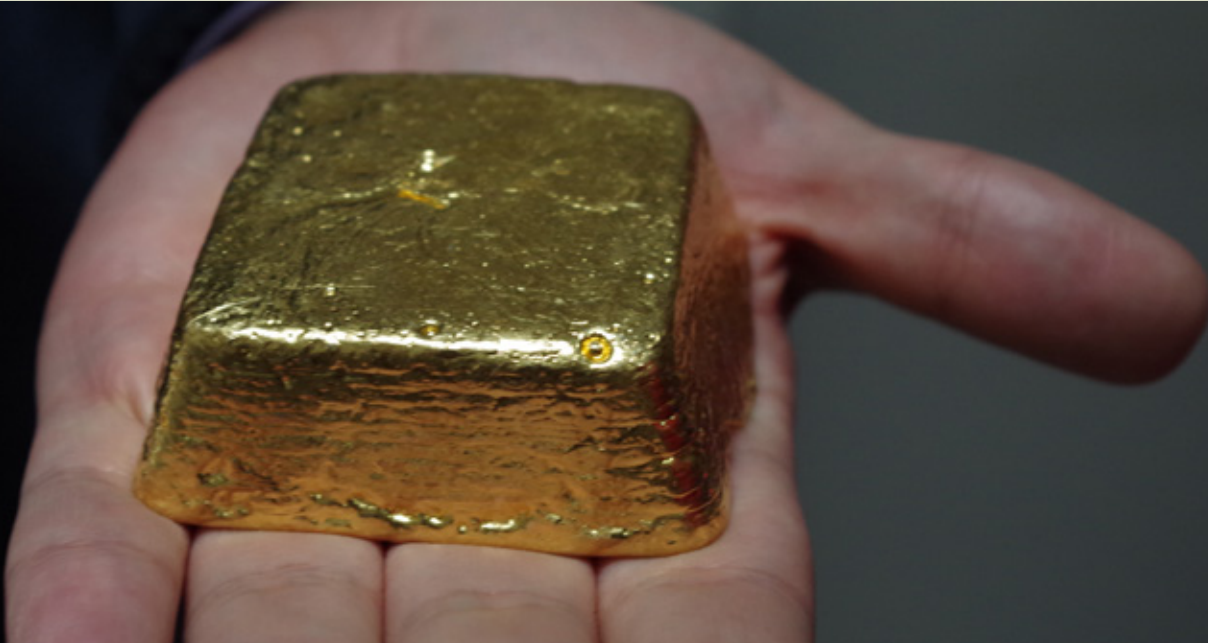

Social impact

What is “factor 5”?

1 person working in an ASGM supports 5 more people in nearby communities

Gold mining often occurs in remote and impoverished areas with little infrastructure or alternative economic activity. For each person directly employed by an ASGM operation, 5 additional jobs are created from on-site contractors or in the local supply chains. Additionally, national employees make up 95% of the workforce of ASGM producers and this local workforce contributes to a more active business community.

The SBC Fund invests in community well-being and improving public access to infrastructure and social services, as well as the promotion of healthcare and education.

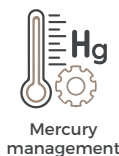
Environmental

Which challenges do we address?



Cyanide is an efficient means for recovering gold and is relatively cheap in comparison with other methods. However, it is highly toxic. Even low exposure can cause serious and possibly fatal health issues. When not properly managed, cyanide also damages the environment, contaminating waters or generating toxic gas.

Swiss Better Gold works with mining operations to help them improve their cyanide management, mitigate these risks and possibly even become certified to international standards.



Mercury – widely used in artisanal and small-scale mines for recovering gold – causes neurological disorders and other health concerns. Mercury also pollutes the environment and water.

Mercury contamination has become a global problem because of widespread and often irresponsible use by miners. These issues are addressed by the **Minamata Convention on Mercury**, a global agreement which, among other objectives, aims to reduce and gradually eliminate mercury.

Swiss Better Gold provides its partner operations with technical assistance in order to comply with the practices established by the Minamata Convention. We focus on projects that reduce, and eradicate, the use of mercury in the gold recovery process, e.g. implementation of gravimetric methods such as gravimetric tables.

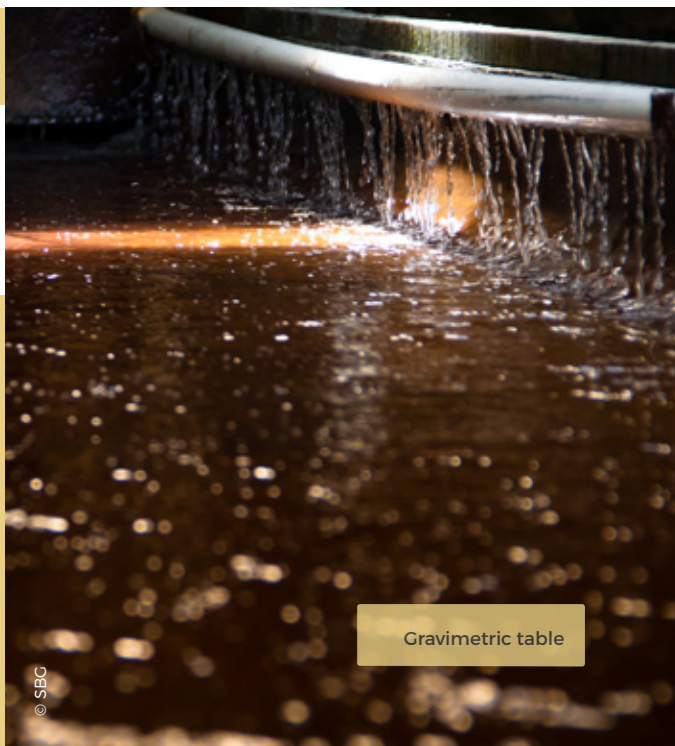

What we aim to achieve through improved cyanide management

Protect human health and the environment by implementing safe management and operating systems, such as contingency plans, inspections, preventive maintenance procedures and working only with International Cyanide Management Code (ICMI) accredited suppliers

Protect beneficial uses of groundwater by implementing measures to manage seepage from cyanide facilities

Provide spill prevention and containment measures for processing tanks and piping

Comply with the ICMI – recognised as the highest standard for cyanide management – by improving and adapting cyanide processing plant infrastructure

Train workers in the responsible use of cyanide and related protocols

Contribute to improved relations with communities by preventing damage to the environment



What we aim to achieve through improved mercury management

Follow the recommendations of the Minamata Convention by training operations and miners in the use of alternatives in order to reduce, and over time eliminate, mercury

Protect human health and the environment

Improve recovery rates as mercury is not necessarily the most effective means to recover gold

This project has been useful to promote greater interrelation between internal and external stakeholders. Regarding internal stakeholders, workers apply best business practices as defined in the Code of Conduct. Regarding external stakeholders, the project has improved communication, such as the exchange of information on cyanide management and transportation.

This has enabled us to launch a new process, which is important to us from a social and environmental point of view.



SBC's significant contribution to the investment has supported the upgrade of our processing plant with new equipment and infrastructure.

For instance, the RJC certification is a challenge that we accept with great optimism and with the certainty that when we work hand in hand with international standards, we share a common goal: sustainable development for all parties and responsible gold production. Implementation of the cyanide code will lead to a cleaner operation that complies with the highest standards – prioritising care for the environment, health and safety of our employees and our stakeholders, which we complement with specific training.



Social

Which challenges do we address?



ASGM operations often lack knowledge of local regulations regarding workers' rights, working conditions and **human rights**. At Swiss Better Gold we support mining operations in properly monitoring and applying **fair working conditions** which guarantee access to health, risk insurance, pensions or fair wages, among others.

Access to education

Many mining communities are located in remote areas where access to education is limited or nonexistent. Low skill levels are an obstacle to economic development as people are employed primarily in poorly-paid occupations such as farming, or resort to illegal activity, for instance illegal mining. **Access to education can provide more opportunities**, as well as better and safer perspectives for these communities. At SBC we want to support communities, that depend on mining, in promoting educational programmes for children as well as adults.

Living conditions

In remote mining areas, infrastructure is often insufficient or lacking completely, with no guarantee of access to water or electricity. Together with our partner mines, Swiss Better Gold works to **improve the harsh living conditions** of these communities. Additionally, providing infrastructure often has a positive impact on relations between the nearby communities and the mining operations.

The **Integral Education Programme** developed with our internal and external stakeholders directly **benefits seven children and nineteen teenagers and adults** in El Pescado village. The programme also includes thirteen of our employees who previously carried out mining and sawmilling activities and were therefore unable to finish their education.

The region around Touchstone, characterised by scattered communities, is generally lacking in adequate infrastructure, such as a school or a teacher.

Touchstone Colombia's Social Management Department set out to identify the needs of El Pescado village. Since most adults cannot read or write, and because many children do not attend school (the nearest school is a three to four-hour horse ride away), **we identified education as one of our priorities** with regard to social investment and contributing to the region's development.



We identified education as one of our priorities with regard to social investment and contributing to the region's development.

Education is one of the most important pillars of Touchstone Colombia's Social Management Plan. It goes beyond academic training: we want to transform lives, generating meaningful social impact, which supports communities abandoned by the government. These are communities with strong socioeconomic and socio-political conflicts and which have been heavily affected by the armed conflict. We want to contribute to **forming proactive communities**, whose arts and crafts can be professionalised, **generating social and economic transformation** of the region where everyone has equal opportunities and can participate in and decide on the future of their communities.

Our experience with Swiss Better Gold has been entirely positive. Not only have we been able to **implement projects** such as the construction of the communal house and the Educational Programme through the premium.

Swiss Better Gold has enabled companies like Touchstone Colombia to turn our gold into "traceable gold", showing us that sustainability is only possible when the social, environmental and financial dimensions enable participation and integration between communities and companies.

The Chalhuane mine is operated by Minera Chalhuane S.A.C. and is located in the Sangre Toro region in Arequipa, Peru. Operations started in 2010.

The mine used diesel generators for its energy supply, which meant large CO₂ emissions. Diesel consumption amounted to 358.4 gallons per day. Costs per kWh were extremely high and the mine could only use the generators for 14 hours per day.

Electricity enables increased integration of renewables and is therefore the most effective way to decarbonise economic sectors, such as mining, at low cost.

to the interconnected power lines to SEAL, the energy supplier, were instrumental in reducing the mine’s carbon footprint to an estimated 1,091.79 tons of CO₂ per year. This is 60-70% of Chalhuane’s total emissions. Operating costs have also been significantly reduced.

This project takes the company closer to meeting its decarbonisation objective and in doing so contributes to achieving the Paris Agreement goals.

In doing so we have been able to establish an industry benchmark in product traceability. Along the way, we have been able to contribute an impact premium which is **supporting infrastructure and educational programmes** in the community around the Touchstone mine in Colombia, and the **construction of a medical centre** in a mining community in Peru.

We look forward to building upon this strong precedent in order to continue to develop our approach to sustainability, hand in hand with the Swiss Better Gold Association, and deliver shared value for stakeholders across the value chain.

Through Swiss Better Gold, Cartier has a unique partnership with a responsible small-scale mining operation in Peru. At end 2022, the **gold purchase premium paid by Cartier since this partnership began amounted to USD 5.8 million**. This money has helped finance numerous projects that have benefited workers and the local community. For instance, one of the projects brought electricity to the mine and local village, which helped reduce the mine's carbon footprint by 62%.

Experiences gained or lessons learned on your journey with Swiss Better Gold:

Thanks to our long-term partnership with the gold mine, we have a better understanding of the actions that can produce a positive impact on the gold value chain and for surrounding communities. In March 2022, representatives of the Sotrami mine came to Switzerland from Peru to visit the Cartier Watchmaking Manufacture, where they discovered the craftsmanship behind the Maison's creations and how gold is transformed downstream. Everyone was delighted by this experience which brought both ends of the supply chain – miners and watchmakers – together.

Thanks to SBG's successful mine-to-market system, we have reached our goal of **sourcing more than 60% of our gold from artisanal and small-scale mines** in South America. By sourcing gold from ASM as part of the Swiss Better Gold system, we achieve two objectives. First, traceability which enables us to deliver a transparent and reassuring message to our clients. Second, generate a positive impact by promoting responsible mining

practices. We have also been able to contribute to improving the mining communities' livelihood thanks to the premium paid when purchasing their gold. These achievements were made possible by our strong partnership.

Experiences gained or lessons learned on your journey with Swiss Better Gold:

On our journey with Swiss Better Gold, we have learned that successful and sustainable ASM sourcing projects require a set of multiple factors, such as policy dialogue to unlock some situations in the country of operation; the incentive given to the mines to implement responsible mining practices; and the essential network with the end-market to increase demand for ASM responsible gold. The opportunity to travel to the mine sites with Swiss Better Gold, and meet with miners and communities, has given us important insight. This helps us to better understand the challenges these people face and the true complexity of these projects. Speaking

of which, we have also learned that, **with the right partners, a complex sourcing project, such as the one with the Barequeros, is possible.** Since 2019, 800 artisanal gold panners using traditional alluvial mining techniques in El Chocó, Colombia, have joined the Swiss Better Gold Initiative. Thanks to our partners' innovative due diligence practices and the determination, alongside the Barequeros, to adopt social and environmental criteria, we have been sourcing gold from this fully traceable and responsible international supply chain for more than three years.

Improving traceability: the barequeros and gold panning

Panning is an environmentally friendly way to recover gold by hand, without the use of chemical substances. However, gold panners (or barequeros) are often not officially recognised, and work and live in difficult conditions. Swiss Better Gold supports the barequeros communities in meeting Swiss Better Gold criteria, such as «Fair wages», «Decent working conditions» and “No child labour”. In collaboration with an International Trader Grupo Altea, the Initiative has also assisted the barequeros with opening bank accounts: a big step towards formalisation. This financial traceability enhances full transparency, from the river to the end consumer.
